## **SEASONAL INFLUENZA PREVENTION IN OLDER ADULTS IN YOUR CARE: ADDRESSING THE CHALLENGE** *Supported by Seqirus.*

**Speaker:** Stefan Gravenstein, MD, MPH, Professor, Departments of Medicine and Health Services Policy and Practice, Brown University

Dr. Stefan Gravenstein is a Professor of Medicine and Public Health at Brown University, an adjunct Professor of Medicine, Case Western Reserve University, and former Director, Center of Geriatrics and Palliative Care at University Hospitals Cleveland Medical Center. He completed his internal medicine residency and geriatrics fellowship at the University of Wisconsin-Madison and William S Middleton Veterans Administration Medical Center, where he joined the faculty and was tenured prior to joining Eastern Virginia Medical School. At EVMS he became the John Franklin Chair of Geriatrics, Director of the Glennan Center for Geriatrics and Gerontology until being recruited to Brown University in Providence, RI. There he became the Clinical Director of the Centers for Medicare and Medicaid Quality Improvement Organization and Network, Quality Partners of Rhode Island (now Healthcentric Advisors), which oversees quality improvement work for CMS in New England.

Academically, he has been a clinical educator and researcher since completing his fellowship in 1987. His primary research focus has revolved around immune senescence, vaccines, and quality improvement, with a particular focus on the long-term care setting and relating to influenza and infection. His currently funded work relates to vaccines and antibiotic stewardship in long-term care settings; and new work relates to pragmatic trials and epidemiologic work leading to new vaccines.
